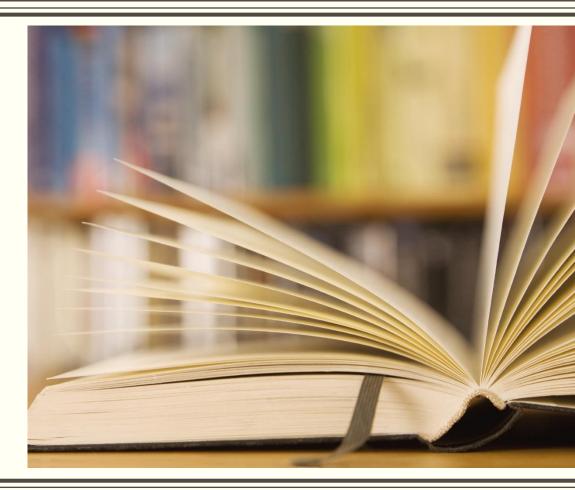

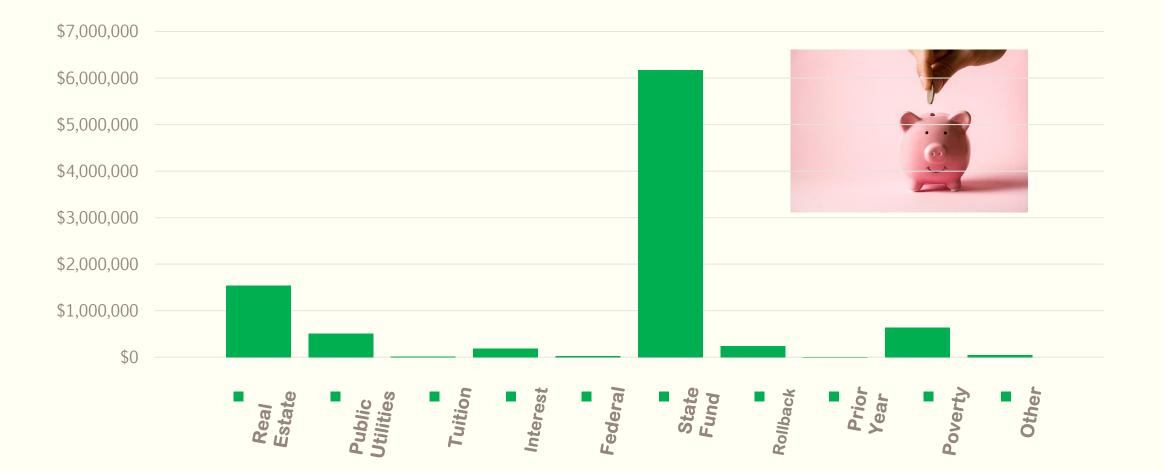

Fiscal Year 2024 (5 months) total revenues are on budget: 42.11% (42%)

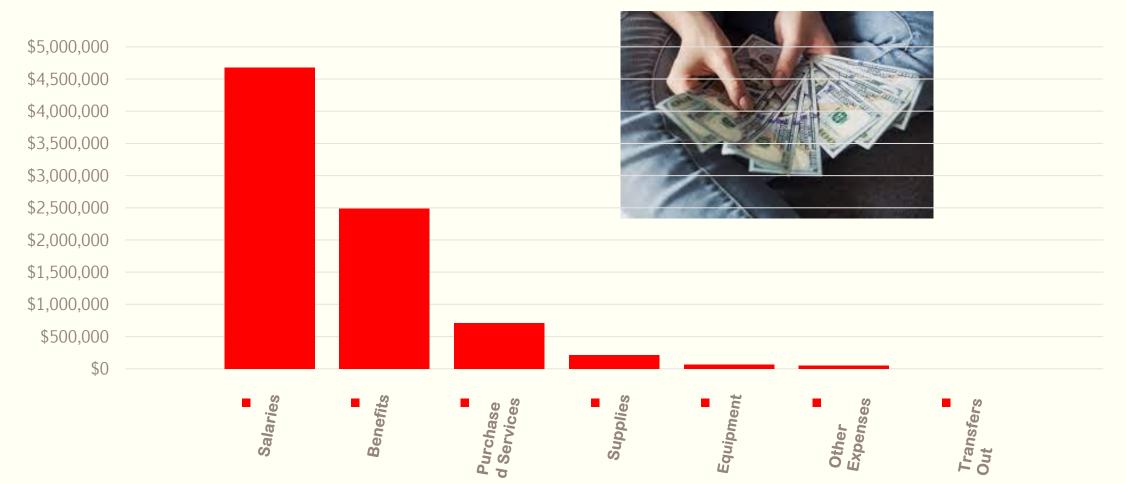
FY24 is up 4.45% over FY23; Interest FY24 \$188,962



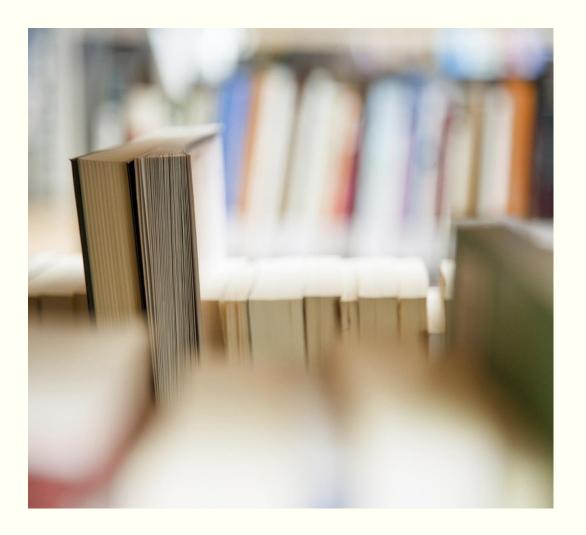
## **GENERAL FUND EXPENDITURES**
